Academic progress is reported to parents via:

- Important announcements will continue through the SchoolReach telephone program
- School web site and social media pages will be the primary means for daily announcements.
- Annual Title I meeting will be held each year in first quarter.
 - At this meeting, families will be informed of the school’s Title I program and budget, and the right of parents/guardians to be involved in their child’s education

Parents can make suggestions and participate in decision making via :

School Responsibilities

• Provide high-quality curriculum and instruction in a supportive and effective remote learning environment that enables the participating children to meet the State's student academic achievement standards as follows:

- Virtual Conferences and staff development developed by our Harmony Instructional Leaders in accordance with public health guidelines (via Zoom).
- Virtual formal Parent-Teacher conferences will be held once per semester in accordance with public health guidelines (via Zoom).
- Virtual Annual Title I meeting will be held each year in first quarter (via Zoom).
 - At this meeting, families will be informed of the school's Title I program and budget, and the right of parents/guardians to be involved in their child's education

Parent Responsibilities

We, as parents, will support our children's virtual learning in the following ways:

- Remind scholars that for safety purposes the camera should remain on during the live lessons. We want to ensure that the person whose name appears on the screen is in fact the person who is connected.
- Take the time to help your scholars rename themselves on zoom (first and last name only) please teach them how to do this.
- Remind scholars that even though they are at home they are still attending their classes so just like on campus they need to put away any items that may cause any distractions during these lessons. Including but not limited to cell phones or other devices not allowed on campus or to be used during class time.

- We encourage parents to remain nearby to help their scholars, especially the younger ones who may take a bit longer to learn how to navigate through all these new programs on their own.
- We respectfully ask that you refrain from sitting anywhere where you may appear in the video frame, and that you allow for your scholar to be the only one that asks questions during the live lessons.

Student Responsibilities

We, as students, will share the responsibility to improve our academic achievement and achieve the State’s high standards. Specifically, during live sessions, we will:

- Attend sessions regularly, be ready to engage in virtual learning and do our best
- Have the camera on, mic off
- Dress and behave appropriately
- Be on time, communicate through chat, use respectful language
- Remove distractions, use headphones, select a good location with good internet connection and power supply
- Have all material required nearby before the session
- Participate during lessons using online tools
